The legal education system in India offers different courses at different levels, starting from undergraduate level to postgraduate and doctoral levels. The most popular course in Law is the Bachelor of Laws (LLB), which is a three-year undergraduate programme. To pursue an LLB course, a student must have completed a graduation degree in any discipline. The (minimum) percentage requirement for General category candidates ranges from 45% to 55% and that for SC/ST category candidates ranges between 35% and 45%. Other than this, some colleges also fix a minimum percentage requirement that candidates need to fulfill in order to secure admission in the three-year LLB course offered by them.
